Sub : Police Estt. – Designating Sr.CPOs (Grade ASIs) who have completed 27 years of service, as SI (Grade)–Orders Issued.

As per the directions contained in the Orders cited, sanction is accorded for 'Designating' SCPOs (Grade ASIs) having 27 years of service and working in General Executive Branch, as Sub Inspector of Police (Grade) subject to the following conditions.

1. The SCPOs (Grade ASIs) must have completed a total of 27 years of service, including basic training period.
- 2) The SCPOs (Grade ASIs) must be drawing a pay scale equal to or higher than that of a Sub Inspector of Police.

Accordingly, the following SCPOs/CPO of this District who are found eligible for designation as Grade Sub Inspector of Police are hereby 'Designated' as SIs (Grade) with effect from the date noted in column No.7.

SI of Police (Grade) will be 'Personal Rank' of the persons so designated.

The persons so designated will be eligible to wear the Uniform of Sub- Inspector of Police and will not be eligible for higher pay and allowances other than what would have been received had they not been designated as SI of police (Grade).

The SCPOs/CPO so designated as Sub Inspector (Grade) will be occupying the lien of the Regular SCPO/CPO post .

They can be entrusted with the duties and responsibilities of a regular Sub Inspector of Police additionally, in such a manner and to such an extent as the State Police Chief may deem fit and appropriate.

They will not be eligible to claim seniority in the cadre of SI of Police (GE) on the basis on this designation.
