Temporary promotion of 121 CPOs (GE) to SCPOs (GE) against the existing vacancies of SCPOs/ASIs/50 % of vacancies of SIs considering the Administrative Exigencies was ordered vide this Office DO 1st cited.

Among the 121 SCPOs (GE) who were temporarily promoted, SI No. 65, Sri. Anu, CPO 4375 was already transferred to Kottayam District by Inter District Transfer vide Order 2nd cited. Hence the Temporary Promotion ordered to Sri. Anu, CPO 4375 vide this Office DO 1st cited is hereby canceled.

On verification of this Office Records.,it is found that SI No.27, Sri. Vishnukumar, CPO 4302 ,who was temporarily promoted as SCPO vide the Order cited 1st has **not secured full pass in General HC Test** . Hence Sri. Vishnukumar, SCPO 4302 is reverted as CPO.

As such there are 2 vacancies of the post of SCPO.

Sri. Nassar M., CPO 4274 ,who has been reinstated to service vide Order 6th cited (Serial No.293 of the Select list) and Smt. Antony Josaphine Jezitha, WCPO 4455 (Serial No.23 of the Select list published on 15.03.2018) are temporarily promoted as SCPO (GE) in the existing vacancy.

The present Unit in respect of SI. No.35, Sri. Rajesh K., CPO 4318 was mentioned as 'CBCID OCW III, Palakkad'. It is corrected as 'CBCID HHW II, Palakkad'.

The present Unit in respect of SI. No.59, Sri. Sudheerkumar., CPO 4357 who was transferred to RP, Palakkad vide DGO 4th cited was mentioned as 'CBCID EOW II, Kottayam' . It is corrected as ' RP Palakkad'.

This Office DO 1st cited is modified to this extent.
