Sub : Police Estt. –Designating SCPO (Grade ASI)/ASI who have completed 25 years of service, as SI (Grade) – Orders Issued.

As per the directions contained in the Orders cited, sanction was accorded for 'Designating' SCPOs (Grade ASIs)/ASIs having 25 years of service and working in General Executive Branch, as Sub Inspector of Police (Grade) subject to the following conditions.

1. The SCPO (Grade ASI)/ASI must have completed a total of 25 years of service, including basic training period.
2. The SCPO (Grade ASI)/ASI must be drawing a pay scale equal to or higher than that of a Sub Inspector of Police.

Accordingly, the below Police Personnel of this District, who is found eligible for designation as Grade Sub Inspector of Police is hereby 'Designated' as SI (Grade).

SI of Police (Grade) will be the 'Personal Rank' of the person so designated. The person so designated will be eligible to wear the Uniform of Sub - Inspector of Police and will not be eligible for higher pay and allowances other than what would have been received had he not been designated as SI of police (Grade).

The SCPO (Grade ASI)/ASI so designated as Sub Inspector (Grade) will be occupying the lien of the Regular SCPO /ASI post. He can be entrusted with the duties and responsibilities of a regular Sub Inspector of Police additionally, in such a manner and to such an extent as the State Police Chief may deem fit and appropriate. He will not be eligible to claim seniority/any other benefits in the cadre of SI of Police (GE) on the basis on this designation.
