Sub : First TBHG in promotion scale to CPOs of KCP who were passed the Havildar promotion test – Orders issued on revision (as per PHQ directions).

The Civil police officers of Kerala Civil Police were obtained 1st TBHG only in the unqualified scale on the ground that they are not qualified in promotion test after joining to KCP, as per previous directions from PHQ vide referred 2nd .Now PHQ, directed vide referred 2nd to grant TBHG in qualified Scale considering test qualification prior to KCP ie, reckoning the qualifications in Battalion Havildar Test or AR HC Test. Hence the 1st TBHG to CPOs of KCP is sanctioned in promotion scale subject to their qualification in Havildar Test conducted during their tenure in Armed Police Battalions and the unqualified scale(25200-54000) granted to the following CPOs of KCP who were passed the Havildar promotion test were revised to qualified scale (27800-59400) and granted further increments as detailed below.


