The above promotion is purely on provisional basis and the Police Personnel so promoted is liable to be reverted if found ineligible while revising the Range wise/District wise seniority list of SCPOs / CPOs and for want of vacancies. This Order is also issued subject to the disposal of OA/OP, if any, pending before the KAT/Courts.

They will be on probation for a period of one year within continuous period of two years duty with effect from the date of joining in the promoted post or the date of regularization of the provisional promotion whichever is later. The Officers/SHOs concerned are directed to relive the transferees immediately and they will join duty in the new place of posting forthwith.

**Those who are transferred will join duty availing only 3 days joining time, if they are eligible for such joining time as per Rules. Leave of any kind should not be**



**granted to the transferees without the prior permission of the undersigned. If any transferee enters on leave with a view to evade transfer, he /she shall be dealt on with disciplinary proceedings without notice.**

The officers concerned will report the date of reliving/ joining duty of the incumbents to this office in due course through iAPS. Officers/section concerned will update the details in the iAPS strength management module and e-Roll.
