The Provisional promotion of Civil Police Officer as Senior Civil Police Officer for the period from 01.6.2012 to 31.12.2018 and from 01.01.2019 to 31.12.2022 have been regularized vide the DOs in reference cited first and second respectively. The nature of vacancy arised in respect of Palaniswami, P 4236, was mentioned wrongly in the DO referred 2nd above.
