Sub : Police Estt. - Designating Police Personnel who have completed 20 years of service as ASI (Grade) – Orders issued.

Ref : 1) GO (Ms) No. 142/2006/Home dated 22.08.2006.
2) GO (Ms) No. 279/2012/Home dated 06.11.2012.
3) GO (Rt) No. 1661/2015/Home dated 04.07.2015.
4) GO (Ms) No.161/2019/Home dated 19.10.2019.

As per the directions contained in the Orders cited, sanction is accorded for 'Designating' regular/Grade SCPO/HCs in General Executive, who have passed General HC test and completed 20 years of service and working in General Executive Branch, as Assistant Sub Inspector of Police (Grade) subject to the following conditions.

1.The Regular and Grade SCPO must have completed a total of 20 years of service including basic training period.

2.The regular or Grade SCPOs/HCs in General Executive must be drawing a pay in the scale equal to or higher than that of a Assistant Sub Inspector of Police.

Accordingly, the following Police Officer who are found eligible for designation as Assistant Sub Inspector of Police (Grade) is hereby 'Designated' as ASI (Grade).

The ASI of Police (Grade) will be 'Personal Rank' of the persons so designated. The persons so designated will be eligible to wear the Uniform of Assistant Sub Inspector of Police and will not be eligible for higher pay and allowances other than what would have been received had they not been designated as ASI of Police (Grade).

The regular/Grade SCPO/HCs in General Executive, who are designated as Assistant Sub Inspector (Grade) will be occupying the lien of the post of Regular SCPOs/CPOs, and no other person in the rank of a regular SCPOs or a person designated as SCPO (Grade) can claim promotion against such a post of ASIs

They can be entrusted with the duties and responsibilities of a regular Assistant Sub Inspector of Police additionally, in such a manner and to such an extent as the Director General of Police may deem fit and appropriate.

They will not be eligible to claim seniority in the cadre of ASI of Police (GE) on the basis on this designation.
