Sub : Police Estt. - Grade Designation - AR HCs as AR ASI (Grade) on completion of 20 years of service – Orders issued.

As per the directions contained in the Orders cited, sanction was accorded for 'Designating' Regular/Grade SCPO having 20 years of service and working in Armed Reserve as Reserve Assistant Sub Inspector of Police (Grade) subject to the following conditions.

- 1) The Regular and Grade AR SCPO must have completed a total of 20 years of Service, including basic training period.
- 2) The regular or Grade AR SCPOs must be drawing pay in the scale of pay equal to or higher than that of a Reserve Assistant Sub Inspector of Police.

In the above Circumstances, the following Police personnel of this District A R, Palakkad who is found eligible to be designated as A R Assistant Sub Inspector (Grade) is hereby 'Designated' as RASI (Grade) with effect from the date noted in column No. 10 on completion of 20 years of service.

AR ASI of Police (Grade) will be the 'Personal Rank' of the persons so designated. They will be eligible to wear the Uniform of Assistant Sub - Inspector of Police and will not be eligible for higher pay and allowances other than what would have been received had he not been designated as RASI of Police (Grade). They will be occupying the lien of the Regular SCPOs post, and no other person in the rank of a regular SCPOs or a person designated as SCPO (Grade) can claim promotion against such a post. They can be entrusted with the duties and responsibilities of a regular Assistant Sub Inspector of Police additionally, in such a manner and to such an extent as the Director General of Police may deem fit and appropriate. They will not be eligible to claim seniority in the cadre of RASI of Police (GE) on the basis on this designation.
