2. The CPO/SCPO (Grade ASI)/RSI must be drawing a pay scale equal to or higher than that of a Sub Inspector of Police.

SI of Police (Grade) will be the 'Personal Rank' of the person so designated. The person so designated will be eligible to wear the Uniform of Sub - Inspector of Police and will not be eligible for higher pay and allowances other than what would have been received had he not been designated as SI of police (Grade).

The CPO/SCPO (Grade ASI)/ASI so designated as Sub Inspector (Grade) will be occupying the lien of the Regular CPO/SCPO /ASI post. He can be entrusted with the duties and responsibilities of a regular Sub Inspector of Police additionally, in such a manner and to such an extent as the State Police Chief may deem fit and appropriate. He will not be eligible to claim seniority/any other benefits in the cadre of SI of Police (GE) on the basis on this designation.
